- **The school will :**
- Provide an environment which has been risk assessed in response to the COVID-19 infection. The Risk Assessment will be completed with Compliance Education and the WD Trust.
- Adhere to the social distancing rules as set out by the government as much as we reasonably can.
- Provide a curriculum that meets the needs of your child's well-being, mental health and academic needs.
- Contact parents/carers if your child displays symptoms of COVID-19;
- Inform you if staff or children in your child's 'bubble' test positive for COVID-19 as this will mean you will all need to self-isolate for at least 14 days.
- Continue our clear and consistent approach to rewards and sanctions for children as set out in the Behaviour Policy as well the expectations outlined in this agreement.
- Communicate between home and school through the school website My Ed App, Twitter, Facebook and Instagram.
- If a member of staff shows symptoms or comes into contact with Covid-19 virus they will get tested and self-isolate for the appropriate number of days.

Parent/Carer.....

- **To help my child at school, I know and understand that:**
- If my child, or anyone in my household, shows symptoms of COVID-19, I will not send them to school, we will self-isolate for 14 days as a family, I will get them tested and I will let the school know as soon as possible via telephone.
- If my child shows symptoms of COVID-19 at school, I will collect my child from school immediately. I will get them tested and I will let the school know as soon as possible via telephone.
- On my commute, and when dropping my child off and picking them up, I will adhere to the 2 metre social distancing rules.
- When dropping off and picking up, I will strictly stick to the school timings for my child.
- My child will not bring any items into school with them or take items home from school including mobile phones (students can bring their own lunch but cannot share it).
- I need to support all staff in their efforts to create an 'as safe as possible' environment.
- I will read all messages that are available on website and / or social media.
- I will inform the school of any changes to parents/carers and emergency contacts details.
- I will follow social distancing rules at all times and understand if there is evidence that I have not followed social distancing, my child may lose their place at school.
- If my child is deemed unsafe, he/she will be sent home and cannot return to school until they can be safe.
- I will ensure that my child has clean clothing on every day.

- I will do my best to:**
- Follow our school rules – REPS.
 - Learn and follow the Bubble rules that will keep me safe.
 - Wash my hands or use hand sanitiser as soon as I go into school and when asked by staff for 20 seconds each time.
 - Tell an adult if I feel unwell.
 - Not bring things (including my mobile phone) into school from home, or take things home from school (apart from my lunch).
 - Only use the equipment in my pack.
 - Not mix with any other children in the school that are not in my 'bubble'.
 - Only enter and exit the school building from the designated area.
 - Follow the catch it-bin it-kill it rules coughing and sneezing into elbow or tissue.
 - Always follow the rules to maintain the safety of myself and others.
 - Follow these expectations and know that if I don't, I will be sent home and will not be able to come back into school until I can be safe.
